### A Note from the Chairman

Recruiting good candidates for public office is tough. We have outstanding people in town positions, and our Democratic county legislator Chad Davis works tirelessly on our behalf. But in other legislative districts, the \$8,300 salary (no benefits) may not draw competent people to consider a job that averages 10 hours of work a week and requires campaigning every two years.

Beyond the county level the problem becomes much more serious.



State legislative districts are gerrymandered to favor incumbents, so a challenger starts way behind in party registrations, requiring aggressive TV advertising to catch up. Successful state legislative campaigns can cost \$500,000. Congressional campaigns have reached the \$2 million range.

The capable people we'd like to have representing us typically have careers already. To run for office, you have to put your life on hold for six months, raise astronomical sums of money, and still risk losing in November. Even if you win, you have to start right in fundraising and campaigning for the next election.

As a result, we risk turning politics into a hobby for the wealthy or a career for opportunists willing to represent wealthy interests. Both parties already find it difficult to recruit candidates to run against incumbents.

This is why I believe <u>public campaign financing</u> and <u>redistricting</u> <u>reform</u> are the two most important issues facing us, the keys to taking back our democracy. Every other issue we care about as Democrats will be better served by officials who represent us rather than their private sponsors.

Please join us, to engage with local politics, have fun, and maybe fill one of the vacancies on the town committee! Our meetings are usually the third Wednesday of the month, 7pm, upstairs at the Kirkland Town Library.

Sarah McCullough is seeking re-election as Receiver of Taxes. Sarah has



brought a keen interest to her job, and we are fortunate to have such a capable young person willing to engage in public service. Sarah says that she has found it rewarding being able to assist people with a variety of property tax issues, and she looks forward to another term when she can meet more community members and make improvements to best serve the town.

**Garry Colarusso** brings a valuable depth of experience to his run for a seat on the Town Board. He regularly attends town and county meetings, and as the appointed chair of the town hydrofracking study

group he has been instrumental in bringing Kirkland close to the adoption of zoning regulations to ban hydrofracking activities. He believes in local government that can directly address the needs of its residents, and he looks forward to the opportunities and challenges that face our town.



**Jay Williams** is running for another term as Town Justice. He says that "Town Court may be the only place people come in contact with our State's judicial system." # **Meet our County Legislature Candidates**

**Chad Davis** is running for re-election as County Legislator for District 14. In this newly reconfigured district Chad will represent parts of Kirkland and New Hartford. As County

Legislator Chad has represented Kirkland with energy, hard work, and a grasp of difficult issues, and he has become a vocal leader in the Legislature's Democratic caucus. When asked to highlight an issue of concern on which he had an impact, Chad said: "I am very proud of the legislation that was passed in April, by a vote of 21 to 5, to ban shale gas extraction on County Lands,

His background includes his years as a county legislator, Town of Marshall Supervisor, over 20 years as an educator, and manager of family-owned McLaughlin's and other area clothing stores.

# **Redistricting Strikes Kirkland!**


